Eric - Applications for the [31st Annual Wisconsin Workplace Safety Awards](#), *formerly known as the Corporate Safety Awards*, are open through February 3rd for Wisconsin-based organizations only!

Through this award program, Wisconsin Safety Council honors 10 leaders in our state's business community for achieving excellence in safety & health. Winners display making safety a top priority. They have taken extensive measures to assure their most valuable asset — their employees — are safe on the job.

The Wisconsin Workplace Safety Awards will be based on size of organization AND type of organization. A total of up to 10 grand awards are presented each year.

NEW THIS YEAR

If reporting separate Division/Operations Unit, you may submit only one division versus multiple divisions for your organization. Each unit must maintain separate safety results within the organization. They must also maintain separate/differentiating safety programs.

Please note: Winners from last year are unable to apply the immediate following year. However, in the interim, we ask winners to judge that years' finalists reports.

The WSA selection process involves two phases:

- **Phase I:** Statistical data relating to a company’s incidence rates for the past three years, with an emphasis on current full year’s calendar data, was reviewed and a core group of finalists was selected. Companies below and up to 10% over the National Average within their NAICS code will automatically move on to Phase II. Others will be determined by committee.

- **Phase II:** The finalists — selected by the Workplace Safety Award committee — will be notified and asked to answer a series of subjective questions pertaining to workplace health and safety issues.

Winners in each category will be recognized during the [Annual Safety Conference](#), on April 14-16, 2025 in WI Dells.
